General Participation Conditions

ArtsLibris is the International Fair of Artist's Books, Photo Books, and Self-Publishing, organized by Raíña Lupa Producciones. The organization is responsible for the conception, execution, and administration of the event. Below are the conditions for participating in ArtsLibris ARCOLisboa 2025.

ADMISSION

- The admission of applications and the assignment of spaces are the exclusive responsibility of the fair's organization.
 - The acceptance of the participation application will be notified to the applicant via email.
 - The organization may reject the participation application without the need to justify the refusal.
 - Once the application is accepted, the submission of the completed and signed form, along with the payment of the corresponding amount, will constitute an irrevocable commitment by the applicant and full acceptance of these terms and conditions.

REGISTRATION

- Any incomplete, incorrect, or late payment may result in exclusion from the fair.
 - The prices for the stands are specified in the registration form and do not include VAT. It is the responsibility of the applicant to verify that the amounts are correct at the time of making the payment.
 - The application will not be final until accepted by the organization. A committee will evaluate the application, and once approved, the applicant must pay the total amount for the stand.
 - The participant must submit the required documents within the stipulated deadline. If this is not done, the organizer is not obligated to provide the contractual services.
 - The costs of transporting and/or shipping materials to the fair, both for participants with their own stands and for those sharing a stand or contracted by the organization, will be borne by the participant. In case of returns managed by the fair, the shipping costs will be borne by the participant upon receipt of the shipment.

STAND

The stand includes:

- A module or table, as specified in the registration form.
- Two chairs.
- Stand identification.
- General lighting.

Notes:

At the fairs in Barcelona and Lisbon, drilling holes in the walls is not permitted. Neither at these nor any other editions of ArtsLibris is it allowed to stick vinyl or hang framed works without the authorization of the organization.

If the publisher wishes to announce authors or titles of publications, they must notify the organization in advance. The organization will handle the design and production of the vinyl, with an additional cost for the exhibitor.

CANCELLATIONS

- Withdrawal by a participant must be notified by letter with acknowledgment of receipt to the organization.
- The exhibitor's renunciation of participation will result in the loss of the amounts paid as damages. A partial or full refund may be possible if the stand is reserved by another exhibitor.
- In the event of changes in the dates, venue, or cancellation of the event due to force majeure, unforeseeable economic or social causes, or any other material cause beyond the responsibility of the organizing entity, no claims or indemnities will be accepted.

GENERAL CONDITIONS

- The participant will receive an informational packet by email, with relevant instructions regarding the fair and any other related matters.
- The participant is responsible for insuring their material during transport, setup, and throughout the duration of the fair.
- The participant is responsible for maintaining their stand. In the case of damage caused by negligence or mistreatment of the facilities, the participant will be responsible for the repair costs. Both during the fair and during the dismantling phase, exhibitors must take care of waste and debris removal.
- The fair's venue organizers will provide security at the premises; in any case, the participant is responsible for their belongings and merchandise.
- The participant agrees to respect the setup, opening, and dismantling schedules of ArtsLibris, as agreed between the organization and the fair's hosting entity.
- The participant is required to display their material during the established hours, every day of the fair. Dismantling the stand before the fair ends is not allowed. If this happens, the organization may impose a penalty on the participant.
- The applicant, with sufficient representation authority, agrees to observe the General

CARD PAYMENT SERVICE

ArtsLibris provides a card payment terminal for exhibitors who need it. A 6% commission will be applied to each sale made through the terminal, which will be refunded to the exhibitor via bank transfer with a prior invoice, including VAT specification, and deducting applicable bank fees.
