

## CALL FOR ENTRIES AND PARTICIPATION RULES

### ArtsLibris MACBA Barcelona – October 10, 11, 12, 2025

ArtsLibris Barcelona, the International Fair for Artist Books, Photobooks, and Self-Publishing, will take place on **October 10, 11, 12 at MACBA, Convent dels Àngels**.

We would like to invite you to take part in the 16th edition of ArtsLibris.

ArtsLibris offers a unique opportunity to present your publishing project to the public and meet with colleagues in the professional sector, with the aim of establishing the necessary synergies to grow the cultural fabric of our environment.

The spaces where the stands will be located are: **Capella, Espai Fòrum and Sala Gòtica**, The Seminar sessions will be held in the **Auditori del Macba**.

We encourage you to submit your application by July 14 and to participate in **ArtsLibris Barcelona 2025, the leading artist book fair in the Iberian Peninsula and Southern Europe**.

## **Admission**

The organization of the ArtsLibris Fair is the responsibility of Raíña Lupa Produccions in all matters relating to its conception, management, and administration.

Admission of applications is done through evaluation by the Organizing Committee, which consists of the management team and other external experts.

The assignment of spaces is the exclusive competence of the Fair's Organizing Committee. Acceptance of the participation application will be notified via email to the applicant.

The application to participate in ArtsLibris may be rejected by the organization for reasons of consistency of the publishing project (without any obligation to justify the refusal).

For participation proposals accepted by the Committee, the submission of the completed and signed form, as well as the payment of the participation fee, constitutes an irrevocable commitment by the applicant and implies full acceptance of these conditions.

## **Registration**

Partial and/or incorrect and/or late payment of the fee may result in exclusion from the Fair.

The prices for stands are set in the registration form and do not include VAT. It is the participant's responsibility to ensure that they are correct at the time of payment.

An application will not be final until it has been accepted by the Organizing Committee. This Committee will evaluate the application, and once approved, the applicant must pay the stand fee in two installments.

The participant must send the required documents within the announced deadline. Otherwise, the Organizing Committee is not obligated to provide the contractual services.

Transport and/or shipping to the Fair of publications and other materials, both for participants with a stand and those sharing with others, are at the participant's expense. In the case of returns at the Fair's expense, shipping costs will be paid by the participant upon receipt of the shipment.

## **Stand**

The elements that make up the stand are as follows:

- A module/table, according to the models specified in the registration form;
- Two seats;
- Stand identification;
- General lighting.

## **Cancellations**

Withdrawal of a participant must be notified to the organizer by letter with acknowledgment of receipt.

The exhibitor's withdrawal from the Fair will result in the loss of the amounts accrued as damages. Refunds, partial or total, will only be possible if the stand is acquired by another exhibitor.

In case of change of dates, venue of the event, or cancellation due to force majeure, unforeseeable economic or social causes, or any other material cause beyond the responsibility of the organizing entity, any claims and compensation are excluded.

## **General**

The participant will receive an informative dossier via email, with relevant instructions, both about the Fair and any related topics.

The participant is obliged to insure their works, both during transport and setup, as well as for the duration of the Fair.

The participant is responsible for the maintenance of their stand. In case of damage caused by negligence and/or misuse of the facilities, or failure to deposit their own waste in the designated containers, the participant will bear the repair costs and penalties.

The organization of the venues where the fairs are held will provide security agents, but the participant is responsible for their belongings and merchandise.

The participant agrees to respect the setup, opening, and dismantling schedules of ArtsLibris, as agreed between the organization and the Fair venue entity. The participant is obliged to display their material for the entire duration of the Fair; otherwise, the organization may sanction the participant.

The submission of a participation application necessarily implies the applicant's full and unconditional acceptance of these ArtsLibris conditions, which they declare to know and accept and to which they commit to comply.
